

The general meeting of Forest Park Homeowners' Association was held on 4/1/73 at St. Alexander's Social Hall.

Tom Doyle, president, called the meeting to order. He immedicately turned the meeting over to Mr. Robert McConnell who spoke on "Incorporation into a City."

Mr. McConnell is Farmington Township Supervisor and Chairman of the Farmington Hills Charter Commission.

Some copies of the proposed charter for the City of Farmington Hills were passed out to those attending.

Mr. McConnell explained that the reason for incorporating into a city is to protect our boundaries and the tax base of Industrial Park. He said that it is important for us to know that any city has the right to annex township property. Farmington Township is surrounded by cities.

Information and comments given by Mr. McConnell on the proposed charter were: The City will be governed by a seven man Council. This Council will be elected by the residents of the City. A Mayor will be elected by the Council Members from among their ranks. The Mayor will preside at their meetings and will be recognized as the head of the City Government for all ceremonial purposes. The administrative duties will be handled by a City Manager. This will be a professional man hired for this job. Salaries of the Council members will be \$1,800.00 a year. The annual salary of the Mayor shall be equal to 150% of the annual salary of a Council member. Raises for the Council Members will be decided by the Council but this must be approved by the electorate at the following election. To restrict bureaucracy the government will be limited to five department. These will be: The Department of Finance, The Department of Public Safety, The Department of Public Services, the Department of Planning, and the Special Services. The first three would be in operation immediately and the other two are to take effect later. Responsibilities of these departments would be: Department of Finance: Keeping accounts and financial records; assessments and collection of taxes and special assessments etc.; control and dispursement of City funds; purchasing. An assessor will also be part of this department.

Department of Public Safety: Under this department would come the Police Department, Fire Department and the Division of Human Rescue. The Division of Human Rescue would provide ambulance services in emergency situations. This service would be free for all City residents. FOREST PARK LOG PAGE TEN (10)

The Department of Public Services: This department would be in charge of building and zoning; public works would include water, sewer, sanitation, streets and traffic and building maintenance.

At this point, Mr. McConnell turned to the financial aspect of the charter and how it will affect us. He pointed out the growth of Farmington Township in telling that in 1961 revenue was \$396,000.00 and in 1973 it is \$2.2 million. Revenue for the City of Farmington Hills will be \$3.5Million. Additional revenue for the City will be available because Federal and State returns to cities is higher than to Townships. Increases in our taxes would be \$20.00 a year for a home in the \$30,000.00 range and \$26.00 for a home in the \$40,000.00 range.

Mr. McConnell pointed out that these increases would be paying for better services and the possible loss of Industrial Park to Novi or Farmington City through annexation would always be a threat if we remain a Township. Loss of revenue from this would be great. At this point the meeting turned to a question and answer session. The questions asked and a condensation of the answers are below. <u>Howard Olsen</u>:If we are a City, will free trash pick-up be one of the increased services?

<u>Mr. McConnell</u>:No. The City could contract for private pick-up for half of the present cost but there are no provisions for this now. It would be in future plans.

Howard OlsenWill the spending of the extra State and Federal revenue availa ble as a City be pigeon holed by them for specific purposes? <u>Mr. McConnel</u>l:Road monies are used only for that reason but other revenue will be used as decided locally.

<u>Mrs. Cassidy</u>: Why are we neglected in services when other more affluent areas aren't? This empecially seems true in road or snow removal services.

<u>Mr. McConnel</u>l: The county controls this now but as a City our own officials would have control.

<u>Gary Unruh</u>: In the first year as a city would we have funds to buy equipment such as road geguipment?

<u>Mr. McConnell</u>: No, because of limited taxes to start but we should be able to after two or three years by contracting for them. <u>Gary Unru h</u>:Why was a Council form of government decided on instead of having wards?

<u>Mr. McConnel</u>[Wards encourage graft in the "Help me and I'll help you" attitude. Change in the size of the wards would alter as growth patterns change. Changes in the Township are rapid now because of the growth. The thought was to unify the area instead of fragmenting it as wards might do. After studying all sides of the coin, a Council type of Government was thought best. To insure representation you have to elect good Councilmen and rely on their in frequity.

<u>Bob Douglas</u>: Will the maximum amount of tax mills be adhered to? <u>Mr.McConnel</u>l:Yes. This has to have a vote of the people to change. There would be 6 mills to start and the Council has the power to add a mill a year after that up to a maximum of 10 mills.

Bob Douglas: Will they increase the mills automatically after the first year? Mr. McConnell: No. The Council would have to study the needs and the income and decide at the time. Kay Wensel: Who will the ambulance services be available for? Mr. McConnell: This will be free for all residents of the City of Farmington Hills in emergency situations. Non residents would receive this service if needed but they would be charged for it later. Bob Wieland: Will this service be run by up to date and trained personnel? Mr. McConnell: Definitely. We conferred with hospital administrators in planning this. Trained peramedics will run the program. They will be able to give shots or other first aid on location and then transfer the patient to the hospital. Keith Milam: Can the commission come back with another charter if this charter is turned down at the polls. Mr. McConnell:Yes, within the life of the commission, but this is playing a dangerous game. This Council has until May of 1974 to come up with an acceptable charter. Sam Brownstein: If we become a City Could any of our property be annexed by other communities? Mr. McConnell: No. As a City our boundaries would be secure.

The day to vote on the new proposed City CHarter is May 8.

The meeting was adjourned.
